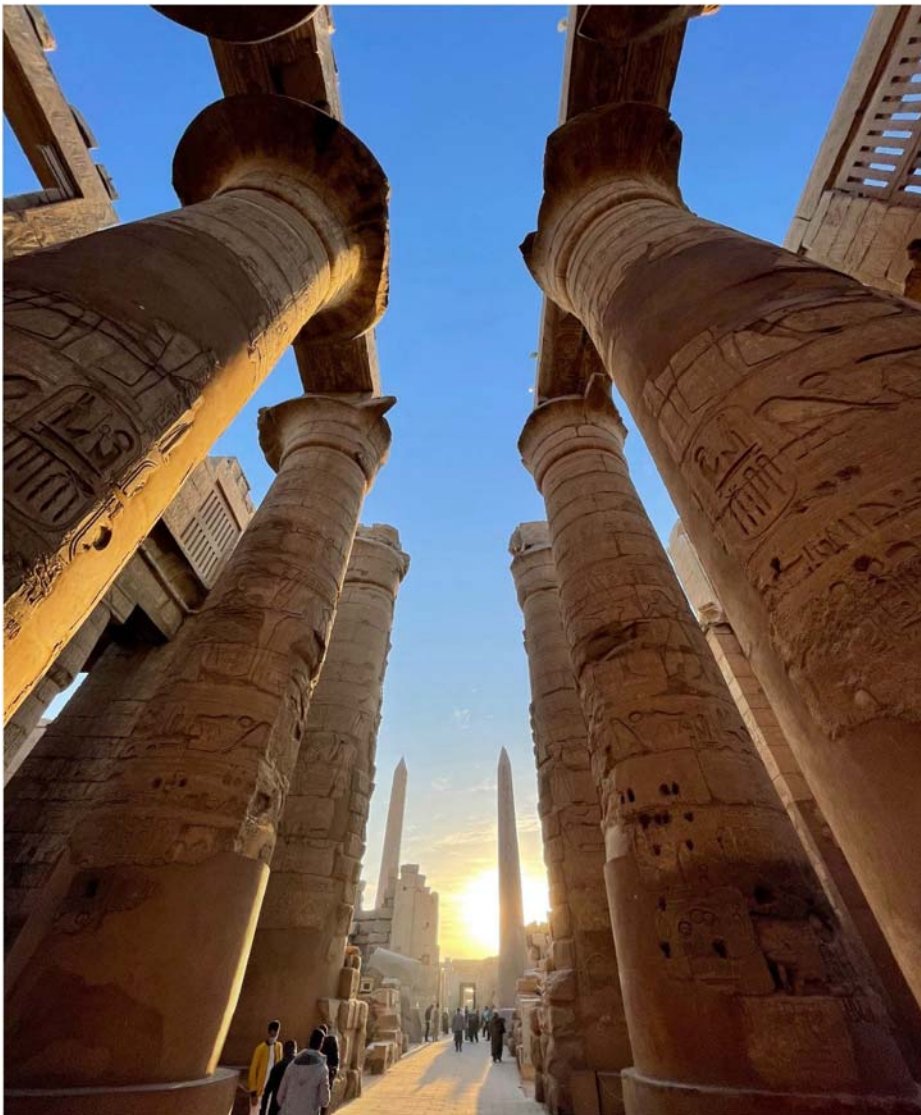

Anthony T. Browder

Anthony Browder has traveled to Egypt over 60 times in four decades and conducted excavations in Luxor for 13 years. He has designed this special tour highlighting the architectural, astronomical and spiritual significance of historic sites in Saqqara, Giza, Abydos and Luxor. This tour is designed especially for travelers who have visited Egypt before and wish to gain a deeper understanding of the pyramids, temples and tombs that will be visited.

We will obtain a special pass to visit all the monuments on the East and West Banks of Luxor and the highlight of our trip will be the Winter Solstice Sunrise at Karnak Temple where you will witness the morning sun illuminate the Holy of Holies of Amun in Ipet Isut.

REQUIREMENTS FOR TRAVEL

PASSPORT – American citizens traveling abroad must have a valid passport. Apply at your nearest passport office or clerk of superior court immediately. Non-American citizens need to check with CTO for requirements.

VISA: EGYPT – A Visa is required; CTO will obtain a group visa for the group.

NON-U.S. Citizens please check with CTO for travel requirements.

VACCINATION: None at this time.

STUDY TOUR

(This tour is designed for returning travelers to Egypt and will highlight select monuments in Saqqara, Giza, Abydos and Luxor only)

Dec 15: THE BEGINNING OF OUR WINTER SOLSTICE THEMED TOUR Leave Washington, Dulles via EgyptAir jet service to Cairo. Meals will be served on board.

Dec 16: INTO THE LAND OF THE PHARAOS / THE EGYPTIAN MUSEUM Arrival in Cairo. You will be met and transferred to your hotel. Afternoon visit to the new Grand Egyptian Museum which contains the world's collection of Egyptian antiquities, dating from the earliest times to the 6th century AD. The collection includes some of the artistic masterpieces of the world, including the treasures of Tut-Ankh-Amun. Return to hotel. *Evening Lecture.*

Dec 17: SAKKARA/GIZA/LUXOR Morning tour to Sakkara. Sakkara's Step Pyramid is the oldest in existence and is the world's first stone building. We will visit the newly opened tombs beneath the Step Pyramid then proceed to Giza. Tour the pyramids of Khufu, Khafra and Menkara and Heremakhet (the Sphinx). Transfer to the airport for a short flight to Luxor. Upon arrival you will be transferred to your hotel. *Evening Lecture.*

Dec 18: TEMPLE OF ABYDOS Leave Waset by bus to visit the Temple of Seti I and the tombs of 25th Kushite royalty. Return to your hotel for dinner.

Dec 19: WASET WEST BANK PT. 1 /VALLEY OF THE KINGS AND NOBLES/ COLOSSI OF MEMNON Morning drive to the Necropolis on the West Bank. Visit royal tombs in the Valley of the Kings and the Temple of Hatshepsut. Return to your hotel for dinner. *Evening Lecture.*

Dec 20: WINTER SOLSTICE SUNRISE AT IPET ISUT (KARNAK) & VISIT THE SOUTHERN IPET (LUXOR) TEMPLE. Participate in the Winter Solstice Sunrise Festivities at Ipet Isut (Karnak). View the gorgeous Hypostyle Hall, the tekhenu (obelisks) of Queen Hatshepsut, and the Sacred Lake. Continue to the Southern Ipet (Temple of Luxor) for a later morning tour then return to your hotel for lunch and dinner. *Evening Lecture.*

Dec 21: WASET WEST BANK PT. 2 ASA RESTORATION PROJECT / DEIR EL MEDINA, & MEDINET HABU Although the ASA Restoration Project is closed for the season, we will circumnavigate the parameter before visiting other Mortuary Temples. Return to your hotel in Luxor for lunch and dinner. *Evening Lecture.*

Dec 22: FREE DAY

Dec 23: LUXOR / CAIRO / WASHINGTON, DULLES Transfer to the airport in time for your return flight home via Cairo.

Dec 24: WASHINGTON, DULLES Arrive at Washington, Dulles Airport at 5:10 AM EST the same day.

TOUR CONDITIONS

AIR TRANSPORTATION: Economy class jet connecting IATA and ATC carriers. Airfare is based on SUPER APEX 6-21 days plus domestic add-on fares where applicable. Airfares are based on February 2022 rates and are subject to change without prior notice.

BAGGAGE: Limited to one normal size suitcase, the weight of which should not exceed 50 pounds. Flight bags, cosmetic bags, briefcases, and camera cases remain in the personal care of tour members and are not included in the 50 pounds.

HOTEL ACCOMMODATIONS: Superior First Class Hotels, two persons sharing a twin bedroom with private bath. A limited number of single rooms are available at \$875.00 supplemental cost. Confirmation required before departure.

MEALS: TWO MEALS PER DAY: Full breakfast and dinner daily.

SIGHTSEEING: As detailed in the itinerary, using comfortable and convenient transportation. English speaking government licensed guide. All entrance fees are included when applicable to specified sites.

TIPS: Tips associated with portage at the hotels, meal gratuities, GUIDES and DRIVERS rendering services TOTALING \$150.00 are included.

TAXES: Service charges as imposed by lodging facilities, taxes by local administrations and government authorities on lodging are included on all services rendered to the group. Airport taxes, and fuel surcharge totaling \$700.00 are included in the price of the tour and are subject to change without prior notice. Visa fee \$30.00 is included.

THE TOUR PRICE DOES NOT INCLUDE: Expense of passports, laundry, Covid PCR tests, wines, liquors, mineral water, lunches and after supper coffee or tea or items not found on the menu, excessive baggage expenses, and all items of a personal nature, plus those not listed as being included in the tour price.

BOOKING AND CONDITIONS: Deposit and payment. A deposit of \$300.00 per person is required at the time of booking. Final payment must be made no later than 60 days prior to departure.

Payments received after the deadline date will be subject to \$50.00 administrative fee, CTO reserves the right to cancel any passenger NOT paid in full 60 days prior to departure. Reinstatement of a passenger is considered a last minute booking.

Last minute booking, 60 days or less prior to departure will have to pay the applicable airfare at the time of booking and \$150.00 to cover administrative cost.

CANCELLATIONS: Cancellations must be made in writing. Cancellations made up to 60 days prior to departure, refunds will be made less \$100.00 per person administrative fee. Cancellations made 59-36 days prior to departure will be subject to \$300.00 per person administrative fee. Cancellations received 35 days or less prior to departure have to pay a charge equivalent to 75% of the cost of the basic tour from the Gateway City.
